REGISTRATION

In order to register to the **Perspectives on GPU Computing in Science**, please fill in the online registration form.

The deadline for the online registration is September 15th at midnight (CET). Early-Bird registration deadline is August 15th at midnight (CET).

ATTENTION!!!

BEFORE STARTING THE REGISTRATION PROCESS YOU SHOULD KNOW THAT:

REGISTRATION FEES

Standard fees do not include conference dinner on September 27th 2016.

Extra fees include conference dinner on September September 27th 2016.

Both Standard and Extra registration fees include lunches, coffee and tea breaks.

Participants can buy conference dinner for accompanying persons in the Events section.

MAXIMUM TIME AVAILABLE TO FILL IN THE REGISTRATION FORM: 20 MINUTES.

If you exceed the maximum time available, you will need to fill in the form again.

YOU WILL BE ASKED TO PROVIDE PRECISE INVOICING DATA:

You can choose the terms of payment (bank transfer or credit card) for your registration and events reservation.

You can also choose the invoice heading for each service. You will receive separate invoices for each service requested.

Should you choose to pay for all the services by bank transfer, you DO NOT need to make separate bank transfers.

Should you pay for some or all the services by credit card, the bank will charge an additional 4% fee. In this case, you will also receive an invoice for bank commissions (VAT excluded).

The invoice for the credit card commissions will be headed as the one of the service it relates to.

The invoice data you will provide during the registration process are the data that will be effectively used for the invoice.



If your registration fee will be covered by your University/Company/Institution, you must provide the Secretariat with the correct details (please do not forget the VAT number).

You can ask for an invoice VAT excluded if your University/Company/Institution belongs to an INTRASTAT Country; again, in order to do that you will be asked its VAT number (the Secretariat will not accept requests of VAT reimbursement).

While completing the *Invoice section* of the online registration form, you can choose among the following options:

- "Participant", if you are going to pay for your own expenses of registration and/or events.

 You can also select "Participant" to pay for your events and head the invoice of your registration fee to your Company.
- "Company with VAT exemption", if you belong to a company registered to the Intrastat system and your company is going to pay for your registration fee. Your company's VAT no. is mandatory.
- "Company without VAT exemption", if you belong to a company not registered to the Intrastat system and your company is going to pay for your registration fee. Your company's VAT no. is mandatory.
